*CHIEFTAINCY (MEMBERSHIP OF REGIONAL
HOUSES OF CHIEFS) INSTRUMENT, 2013*

IN exercise of the power conferred on the National House of Chiefs by section 6 of the Chieftaincy Act, 2008 (Act 759), this Instrument is made this 17th day of July, 2013.

Membership of Regional House of Chiefs

1. Membership of a Regional House of Chiefs does not affect the status of a chief and shall not be construed to confer paramountcy on any chief or to prejudice the claim of a person to the status of a chief.
