CUSTOMS (AMENDMENT) ACT, 2017

AN ACT to amend the Customs Act, 2015 (Act 891) to provide for a zero-rate of duty payable on specific imported vehicular parts in the First Schedule.

PASSED by Parliament and assented to by the President:
